This matter came on at this time to be heard and it appearing to the court that this is the seventh day after an Election was held in the above entitled matter, and the day fixed by law for canvassing said Election Returns.

It further appearing to the Court from said canvass that the result of the canvass is as follows:-

300 For Formation Of District 6-----65 votes.
301 Against Formation of District ----- 0 votes.

That the majority in favor of formation of said District is 65 votes.

It Is Hereby Ordered and Declared that the Crescent Rural Fire Protection District be and the same is hereby formed and established, being described as follows:-

A tract of land lying in Klamath County, State of Oregon in Sections 30 and 31, T. 24S, R. 9E W.M. and Section 36, T. 24S, R. 8E. W.M. and more particularly described as follows:

Beginning at an Iron Pipe 938.87 ft. more or less East of the 1/4 corner, Section 19 and 30, T. 24S, R. 9E., W.M. thence on the Section line S. 89^b, 43' E. for a distance of 380 ft. more or less to the East 1/16 corner, Sections 19 and 30;

Thence Southerly along the East 1/16 line, Section 30 for a distance of 3960 ft. more or less to the S.E. 1/16 corner of Section 30;

Thence westerly for a distance of 1320 ft. more or less to the S. 1/16 corner Section 30;

Thence approximately S. 36¹/₂^o West for a distance of 1650 ft. more or less to a point approximately 975 ft. west of the 1/4 corner of Section 30 and 31;

Thence west along the Section Line of Section 30 and 31 for a distance of 300 ft. more or less to a point 300 ft. East of the easterly r/w line of U. S. Highway 97;

Thence Southerly following a line 300 ft. East of the Easterly r/w line of U.S. Highway 97 for a distance of 5940 ft. more or less to a point 300 ft. East of the Easterly r/w line U. S. Highway 97 which point is more or less 1050 ft. west of the S. E. corner Section 36, T. 24S, R. 8E., W.M.;

Thence west along the South line of Section 36, T. 24S., R. 8E., W.M., to a point 300 ft. west of the westerly r/w line U. S. Highway 97;

Thence Northerly following a line 300 ft. west of the westerly r/w line of U. S. Highway 97 for a distance of 2880 ft. more or less to the East and West 1/4 line of Section 36;

Thence East for a distance of 340 ft. more or less to the Westerly R/W. line of U. S. Highway 97;

Thence Northerly along the West R/W line of U. S. Highway 97 for a distance of 1460 ft. more or less to a point 1220 ft. more or less North of 1/4 corner, Section 31, T. 24S., R. 9E. W.M. and Section 36, T. 24S, R. 8E., W.M.;

Thence North on the Section to the Section corner, Sections 36 and 25., T. 24S., R. 8E., W.M. and Sections 30 and 31, T. 24S., R. 9E., W.M.;

Thence East for a distance of 350 ft. more or less to the Eastern R/W of the Klamath Northern R. R. - excluding that portion of land occupied by the Klamath Northern R. R.;

Thence northerly following the East R/W line of the Klamath Northern R. R. Co. for a distance of 1800 ft. more or less to an intersection with the Gilchrist Timber Company fence which is the old Oregon Trunk R. R. which point is 200 ft. more or less westerly along the East and West 1/2 line from the center of Section 30;
